



Trivia at the Drive in presented by Verizon Official Rules

**NO PURCHASE NECESSARY TO PLAY OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

The **Trivia at the Drive In presented by Verizon** is intended solely for participants in attendance at the Verizon® Drive In event located at the **Topsfield Fairground** (the “Event”) at 207 Boston St., Topsfield, MA 01983 (“Event Location”) on August 18, 2021 through August 22, 2021 (the “Trivia Game”). The Trivia Game consists of five Daily Trivia Game Periods. The Daily Trivia Game Period consists of trivia games with three Rounds of play (each, a Game Period or “Game”) as set forth below:

**GAME PERIODS: All times are Eastern Time and approximate. All Game Periods begin approximately thirty minutes to one hour prior to the start time of each movie and end prior to the start time of each movie as outline in the chart below.**

**ELIGIBILITY:** The Trivia Game is open to legal residents of the fifty United States, and the District of Columbia who are at least the age of majority in the state in which you reside (this is 18 years of age in most states) at the time of Trivia Game participation and who are in attendance at the Event. Employees (including, but not limited to, consultants, independent contractors, “temporary employees,” former employees and interns) of Verizon Services Group Inc. (“Sponsor”), Topsfield Fairgrounds Drive In and their respective parents, subsidiaries, affiliates, authorized agents, retailers, sales representatives, distributors, suppliers, advertising and promotion agencies, and each such individual’s immediate family members and those living in their same households, whether or not related, and all individuals who have, within the past six months, performed services for Sponsor agencies (hereafter collectively, “Promotion Entities”) are not eligible to play or win. “Immediate family” members include spouses, grandparents, parents, children and grandchildren, whether by marriage, past marriages, remarriage, adoption, cohabitation or other family extension. Non-eligibility will result in disqualification if discovered by Sponsor. You must have a personal mobile device enabled with Wi-Fi or Data (“Mobile Device) in order to participate.

**HOW TO ENTER:** During the Trivia Period, there will be a prompt on the drive-in screen with instructions on how to participate including a code (“Game Code”) and the website address (“URL”). On your Mobile Device, visit the URL provided (“Website”) and enter the Game Code. You will then be instructed to register by providing the required information and agreeing to the Official Rules and Sponsor’s privacy policy and clicking “Submit”. Return visitors will need to enter only the Game Code and their phone number.

**HOW TO PLAY:** The objective of the Trivia Game is to correctly answer each question during each Game Period. Limit one Trivia Game play (“Game Play”) per Game Period per person. You must be registered prior to the start of a Game Period in order to participate in that Game. Once a Game starts you will not be able to register until the next Game Period. If you have already registered and played a Game, you will not be required to register again, and Game Play will automatically start.

- Entrants who failed to enter / sign up prior to the start of Game Play will be locked out until the next Game Period.
- Each Game Period will consist of 5 questions each round that will be shown on the theater screen with corresponding possible answers displayed on your Mobile Device.
- The first question will appear on the main screen with available answers on your Mobile Device.

• Tap the answer you believe to be correct within the allotted time and then wait for the countdown to finish to discover if your answers are correct.

If there is a leaderboard, the leaderboard will be for entertainment purposes only, and the Verizon Official Representative will determine correct answers and winners in his or her sole discretion. The Verizon Official Representative's decisions are final and binding.

**WINNING:** There will be a total of (6) winners per Game Period. The two entrants with the most correct answers in each Round will each receive a prize. All properly claimed prizes will be awarded, provided there are a sufficient number of eligible entries per Game Period, but in no event will more prizes be awarded than are provided for in these Official Rules. You must be present to play, but you need not be present to be deemed a winner. Entries will not carry over from one Game Period to the next.

If there is a tie for a prize, the winner will be determined based on the collective time it took each tied entrant to answer all questions, and the prize will be awarded accordingly.

A \$25 Verizon Gift Card. Gift card will be awarded in the form a Gift Card Code. Gift card can be used to buy merchandise & services at stores/kiosks operated by Verizon or at Verizon.com. **CLAIMING & AWARDING PRIZES:** Sponsor will attempt to notify potential winners within 10 days from winner determination via email using information provided during registration. The notification will include a prize claim link. Potential winner must follow the link in the prize claim form in order to claim their prize. Potential winner will be asked to enter the e-mail address used during registration within 10 days of the time the notification email is sent. Once confirmed, potential winner will be prompted to enter winner's address information and submit. Once potential winner information has been validated, the prize code will be sent via the email address provided during registration. If potential winner is not in compliance with these Official Rules, including eligibility requirements, if prize notification or attempted notification is returned as undeliverable, if potential winner does not complete prize claim form within 10 days of the time the or if potential winner declines prize offered, the prize may be forfeited. An alternate prize winner may be designated by Sponsor applying the criteria set forth above if time permits. By participating in the Trivia Game, all entrants acknowledge compliance with and agree to be bound by these Official Rules, and the decisions of Sponsor and/or judges, which are final in all respects. Sponsor not responsible for loss, delay, or damage in delivery of prizes.

**CONDITIONS:** All received registrations and Game Play information become the property of Sponsor. No correspondence will be entered into other than the communications outlined herein. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected Game Plays, which will be disqualified. Persons found tampering (or attempting to tamper) with or abusing any aspect of the Trivia Game, or whom Sponsor believes to be causing malfunction, error, disruption or damage will be disqualified. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source. Sponsor and its subsidiaries; media partners; printers; advertising and promotion agencies; their respective parent, subsidiary and affiliated companies (collectively, the "Released Parties") are not responsible for any: (a) mobile device, computer, printer, hardware, software or programming malfunctions or errors or interrupted or unavailable network, server or other connections, network malfunction, or other technical failures or errors, or failure to properly process Game Plays; (b)

communication disruption or other forces beyond the reasonable control of the Sponsor, including inability to access the Game Play process or use of game devices, or other disruption related to internet traffic, virus, bug, or non-authorized intervention; (c) damage caused by computer virus or otherwise resulting to any computer or mobile device from entrant's access of the registration page, whether human, mechanical or electronic; or (d) incorrect or inaccurate information, whether caused by the entrants or by any of the programming or equipment associated with or used in the Trivia Game. Sponsor reserves the right, in its sole discretion to modify, terminate or suspend this Trivia Game should viruses, bugs, technical errors/problems, force majeure, unauthorized human intervention or other similar causes corrupt or impair the administration, security or fairness of the Trivia Game or if the Event is cancelled or postponed ("Disruption"). If the Trivia Game is subject to Disruption, Sponsor will award the prizes for the Game in process at the time of Disruption by applying the criteria set forth above to all eligible, non-suspect Game Plays for that Game received that are unaffected by the Disruption, provided the Disruption does not prevent this process, and Sponsor will not award prizes for additional Game(s) (if any). Notice of Sponsor action in connection with Disruption will be posted at the Event Location.

**LIMITATIONS OF LIABILITY:** By participating in this Trivia Game, entrants hereby waive and release and agree to hold harmless, the Released Parties and all of their employees, officers, directors, and agents from and against, any and all rights, claims and causes of action whatsoever that they may have, or that may arise, against any of them for any liability for any matter, cause or thing whatsoever, including but not limited to any injury, loss, damage, whether direct, compensatory, incidental or consequential, to person, including death, and/or property, arising in whole or in part, directly or indirectly, from their acceptance, possession, use or misuse of any prize, or their participation in this Trivia Game, or any prize-related activity. By participating in the Trivia Game, entrants (except where prohibited by law) consent to use of name, likeness or biographical information in advertising, promotional or marketing materials without notice or compensation.

**DISPUTES:** As a condition of entering, entrants agree (a) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; (b) all causes of action arising out of or connected with this Trivia Game, or any prize awarded, must be resolved individually, without resort to any form of class action, and exclusively by the appropriate court in New Jersey, to which entrant submits to personal jurisdiction; and (c) any and all claims, judgments, and awards will be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs. Some states do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above limitations or exclusions may not apply to you in whole or in part. If there is a discrepancy or inconsistency between disclosures and other statements contained in any Contest materials and the terms and conditions of these Official Rules, these Official Rules will prevail, govern and control. Any failure by Sponsor to enforce any of these Official Rules will not constitute a waiver of such Official Rules.
